This manufacturer's certification statement is the required documentation for SeriousWindows products as defined by the American Recovery and Reinvestment Act of 2009. How to qualify and claim the 2009 – 2010 Tax Credit and Limitations^{1,2}

1. Purchase and install qualifying SeriousWindows or doors beginning January 1, 2009 through December 31, 2010. Qualifying windows and doors have both a U-Factor of 0.30 or lower and an SHGC of 0.30 or lower.
2. You must have this Manufacturer's Certification Statement to qualify. It is a signed statement from Serious Materials certifying that the product or component listed below qualifies for the 2009-2010 tax credits. Keep a copy of this certification statement and purchase receipts for your records but you do not have to submit a copy with your tax return.
3. Improvements made in 2009 will be claimed on your 2009 taxes (filed by April 15, 2010) using the IRS Tax Form 5695 (2009 version). This form will be available in late 2009 or early 2010.
4. Tax credit is for the cost of the products only – the credit does not include installation costs.
5. Tax credit is 30% of the amount paid for the qualifying product up \$1500.
6. These tax credits are for the taxpayer's principal residence only and do not apply if you are building a new home.
